

Vietnam Veterans of America, Chapter 885 Official Raffle Contest Rules for Offshore Fishing Trip

OFFICIAL CONTEST RULES: By participating, you agree that:

1. These Official Contest Rules may not be waived, modified, or supplemented except by the Vietnam Veterans of America, Chapter 885. No modification of these official contest rules shall be enforceable unless made by the Vietnam Veterans of America, Chapter 885.
2. The raffle drawing shall be held at the Vietnam Veterans of America, Chapter 885 in Wilmington, North Carolina. All tickets must be received by 5:00 PM on the drawing date to be eligible for the drawing.
3. Each ticket will be entered separately in the drawing. Each ticket is a separate and equal chance to win the Offshore Fishing Trip.
4. Prize consists of a Full Day Gulfstream Fishing Excursion for four adults supplied by Winner Boats, Carolina Beach, NC. Trip Departure and Arrival schedules and excursion policies are available from Winner Boats.
5. Winner has 10 days to take delivery of the tickets for the Offshore Fishing Trip in Wilmington, North Carolina, or forfeits all claims thereto.
6. Due to postal regulations, raffle ticket stubs cannot be returned by mail for purchases over the Internet, through the mail or by telephone. When an order is placed, we will complete the ticket by filling in the name, address, and phone number, and we will drop the ticket in the barrel at the Offices of the Vietnam Veterans of America, Chapter 885. At the drawing, the winner will be contacted based on the name and information on the ticket. To pick up the Offshore Fishing trip Tickets, two forms of identification, one of which must be a photo ID will be required to prove that this person is the person on the winning ticket. Purchasers do not need their ticket stubs for any reason. However, the stubs will be kept on file at the Offices of the Vietnam Veterans of America, Chapter 885. Purchasers can call or email info@vva885.org to check when the order was processed and obtain their ticket number if so desired. Tickets can be picked up at the Offices of the Vietnam Veterans of America, Chapter 885 during the hours of 9:00 am to 1:00 pm, Tuesdays and Thursdays.
7. Contest winner notification will be made by telephone and by postal mail.
8. Successive alternate backup winner will be drawn and held by Vietnam Veterans of America, Chapter 885 judges, but not announced in case the first winner does not claim the Offshore Fishing trip within 10 days or is otherwise ineligible.
9. Participant must be at least 18 years old. Contest winner may be required to sign an affidavit of eligibility at the discretion of the Vietnam Veterans of America, Chapter 885.
10. Contest winner is solely responsible for all taxes, insurance, licensing, travel and any other expenses in claiming, and using the Offshore Fishing Trip Tickets. This may include sales and property taxes. The Vietnam Veterans of America, Chapter 885 has no liability with regard to taxes or any other fees associated with the Offshore Fishing Trip.
11. The Vietnam Veterans of America, Chapter 885, has no liability, of any kind, for any accident, injury, or any other mishap incurred while participating in the Offshore Fishing Trip.
12. In the event the Offshore Fishing Trip tickets are lost, damaged, destroyed, or otherwise not available, Vietnam Veterans of America, Chapter 885's liability shall be

limited to refund of ticket price to participants. Vietnam Veterans of America, Chapter 885's liability for any other claim is limited to refund of ticket prices.

13. The Vietnam Veterans of America, Chapter 885 assumes no responsibility for sea or weather conditions, or readiness of the excursion vessel on the scheduled day of the Offshore Fishing Trip. Rescheduling shall be the responsibility of the contest winner in co-operation with Winner Boats.
14. Contest winner agrees to the use of his/her name, address, photographs or videotape likenesses and statements for publicity purposes by Vietnam Veterans of America, Chapter 885, and agrees to sign a publicity release without any further compensation.
15. Vietnam Veterans of America, Chapter 885 reserves the right to cancel this contest at any time, in which event its liability is limited to refund of ticket prices to participants.
16. Any person who engages in conduct designed to corrupt the outcome of a charitable gaming activity with the purpose to defraud, or knowing that he is facilitating a fraud, is guilty of a Class D felony and will be prosecuted to the full extent of the law.
